Our Degloor college is a "College of co- education", which is registered under society act by Govt. of Maharashtra and affiliated to Swami Ramanand Teerth Marathwada University, Nanded. The College has a Governing Body (Adat Vyapari Education Society, Degloor) which is approved by the authority appointed by Govt. of Maharashtra. It runs as per rules and regulations made by the Govt. of Maharashtra/UGC/University from time to time.

The College comes under "Grant in Aid" category. Therefore financial transactions are audited by the CA and Assessed by Joint Director, Higher Education Nanded. It is also audited by Senior Auditor of Higher Education, Nanded and examined by AG Nagpur. The College has different Bodies to maintain all types of disciplines on the campus.

All the committees of the institution are under Statutory Bodies and comes under section 4(1) (b) of RTI Act 2005. The applications under the RTI Act along with a postal order / demand draft for Rs.10.00 obtained in favour of Principal, A. V. Education Society's Degloor College, Degloor may be sent to the Public Information Officer (PIO) or handed over to his office. #### 2. The Power & Duties of Officers and Employees




